

Avantax Online & Mobile Privacy Policy

This policy is effective as of June 30, 2020

Scope and Overview of Policy

This Online and Mobile Privacy Policy ("Policy") applies to your interaction with Avantax Wealth Management, Inc., d/b/a Avantax Wealth ManagementSM, a Blucora company, and the family of Avantax companies (excluding websites operated by Avantax Financial Professionals) (collectively, "Avantax"), at any online or mobile site or application that we own and control, including Client Connect ("Sites"), unless a different online and/or mobile policy is posted at a particular site, or is made available to you and by its terms supplants this Policy. These include the Avantax Privacy Policy for Individuals. Please note that where we have a presence on a site owned by a third party, such as a page or account on a social media site, this Policy shall govern the collection of information and data by Avantax through the Sites and that third party's privacy policy and terms of use will govern the collection and use of data by that third party.

For purposes of this Privacy Policy, "Personal Information" is data specifically about you, which personally identifies you, and which you typically provide on a voluntary basis. Personal Information does not include aggregate or combined information, or Automated Data (as defined below), which is data related to you but does not identify you specifically. By using the Sites or related services, you consent to Avantax's collection, use and sharing of the data as described in this Privacy Policy, which may be updated from time-to-time at the sole discretion of Avantax.

Personal Information We Collect

When you request information by completing one of the available on-line request pages (such as "Contact Avantax", "How can I get started," etc.), we may collect Personal Information, including your name, address, telephone number, email address, or other means to contact you. When you register for and/or use an online service on the Sites, the Sites may collect, or receive from third parties, your contact information and additional information, such as your account number, social security number, financial information (including statements, account balances, and transaction history) submitted by you or others in connection with your use of the Sites, and verification information that we use to identify you.

Our Use and Sharing of Personal Information

Information we collect through the Sites, including Personal Information, may be used to: (i) contact you regarding a request for information that you made; (ii) perform certain tasks and provide services that you requested (for example, correspond with us or review your accounts); (iii) verify your identity when accessing the Sites; (iv) enforce our Terms of Use and any other agreements between you and Avantax; (v) improve, modify, customize, and measure Avantax online services; (vi) compare information for accuracy and verify our records; (vii) detect and prevent fraud or other criminal activities; (viii) market services to you; or (ix) fulfill a lawful purpose.

In connection with these Uses of Personal Information, Avantax may share Personal Information among its affiliates and with Avantax Financial Professionals. Avantax will not share personal information collected through the Sites with non-affiliates without your express authorization except: (i) companies that perform services for us or assist us in servicing your account; (ii) as permitted or required by law; or (iii) in connection with an acquisition, merger, restructuring, sale or other transfer involving all or any portion of Avantax.

Our Collection and Use of Automated Data, Including Cookies and Similar Technology

In addition to the information you provide, Avantax may also automatically collect information about your computer or your activity ("Automatic Data"). For example, we may record how many times you click on a hyperlink, determine whether you visited the Sites from a particular Internet link or advertisement, or track your path through the Sites. This automatic data collection may include but may not be limited to information collected by cookies, IP addresses, log data, browser data, mobile device identifiers, location data, and transparent GIFs.

Cookies are pieces of data stored on your device and are assigned by a web server to the browser on your device. When you return to a site you have visited before, your browser gives this data back to the server.

Typically, once you log out or close your browser, this cookie expires and no longer has any effect. "Persistent" or longer-lasting cookies can be used for other purposes, such as to record user experience preferences when you use a website. These cookies do not expire once you log out or close your browser. You are free to decline cookies if your browser permits, but doing so may interfere with your use of the Sites.

We and our third-party service providers may also use technologies similar to cookies to track your interaction with the Sites and to serve advertising that is relevant to users. Some of these technologies may include web beacons, pixels, tags and Flash objects. As with cookies, you are free to decline such technologies if your browser permits. You should refer to your browser's instructions to remove cached history and images from your device. Deleting or disabling cookies will not remove Flash objects. You should refer to Adobe's website (www.adobe.com) for more information on how to disable these objects.

Some third parties' data collection tools or embedded content, plugins or other technology on the Sites, such as cookies or social media sharing buttons, may allow their operators to learn about your interaction with our Sites, and they may combine this information with other, identifiable information they have collected about your visits to other websites or online services. These third parties may handle this information, and other information they directly collect through their technology, pursuant to their own privacy policies or practices. Avantax may aggregate the Automatic Data it collects from its various users (which does not include your Personal Information) and share it with or sell it to Avantax's affiliates, business partners, and other third parties. The Automatic Data may be used by Avantax or the third parties for research purposes (including to help Avantax improve its products), or any other legitimate business purpose.

Protecting Children's Privacy Online

We do not seek to nor knowingly collect or use Personal Information from children under 13 on the Sites. No part of the Sites is structured to attract anyone under 13. If a child has provided us with Personal Information, a parent or guardian of that child may contact us to have the information deleted from our records.
